CONFERENCE BACKGROUND

The Irish Hotels Federation is hosting the seventh Irish Hotel Investment Conference at the Ballsbridge Hotel, Ballsbridge, Dublin 4, on Wednesday 29th May 2019. Each year this conference provides delegates with expert market insights into important developments in the Irish hotel and finance markets. It is also a forum where you can connect with business leaders and participate in discussions on investment in the Irish hotel industry.

The hotel industry is a key part of infrastructure in Ireland supporting tourism, foreign direct investment, the domestic economy and communities throughout the country. Expectations have been exceeded in the pace of recovery since the economic crash. But uncertainty around BREXIT and other international vulnerabilities provide a cautionary note on downside risks to the economy. While there is still a positive outlook for growth in tourism and the Irish economy, the changing environment has implications for our approach to financial planning and assessing appropriate levels of equity and debt to support sustainable investment.

Government support continues to be vital for tourism, as an indigenous export industry, in order to maintain sustainable growth in overseas revenue, employment, high quality hotel and other infrastructure and at the same time contribute to regional balance.

The conference sessions will cover economic outlook, BREXIT and implications for the Irish hotel industry, the changing landscape in hotel property, investor perspectives on hotel acquisition, return on investment criteria for capital investment projects, profit sustainability, financial planning and hotel debt, hotel industry performance in the past, present and future, personal business planning and industry CEOs' perspectives on how to face current challenges.

Brendan Griffin TD, Minister of State at the Department of Transport, Tourism and Sport with special responsibility for Tourism and Sport will address the conference.

Michael Lennon, IHF President

A fifth generation hotelier with over 25 years' experience in the hotel sector, Michael, together with his wife Joanne McEniff, owns and runs the Westport Woods Hotel, which they bought over twenty years ago. He is a graduate of the College of Catering, Cathal Brugha Street and began his career in Chicago before returning to Ireland, where he initially worked with the Great Southern Hotel Group before joining Brian McEniff Hotels. Michael has been heavily involved in tourism marketing and development with tourism networks in Westport and wider afield in Co Mayo, Sligo and Donegal helping to promote initiatives such as the Wild Atlantic Way at home and abroad. He is a strong advocate of developing similar tourism networks throughout the country.



Myles Dungan, Conference Chairman

Myles has been hosting current affairs, arts, history and sports programmes on radio and television for more than three decades. He made his name as the anchor of RTÉ Radio's drive time news programmes. He now presents The History Show on RTÉ Radio I.
