

Conference Background

The Irish Hotels Federation is hosting the fourth Irish Hotel Investment Conference at the Ballsbridge Hotel, Ballsbridge, Dublin 4, on Thursday 16th June 2016. This Conference has established its reputation for consistently providing delegates with expert market insights into important developments in the Irish hotel and related finance markets and also as a forum where you can connect with business leaders and participate in discussions on investment in the Irish hotel industry.

In 2015 we saw record overseas visitor numbers which have been followed by further increases this year. Room occupancy rates in Dublin are among the highest in Europe although regional rates lag somewhat behind. Over the coming years, sustainable growth and our continued competitiveness will be influenced greatly by the strength of the working relationship between the hotel industry and the capital markets and the orderly elimination of overhanging debt.

The conference sessions will cover the progress being made on restoring financial sustainability to the Irish hotel industry, hotel property trends and investment outlook, hotel performance and investment feasibility, funding gaps and success factors in financing hotels, loan book sales, recent developments in banking solutions and MBOs, hotel investor perspectives and capacity growth in Dublin.

Joe Dolan, IHF President

Joe is the 36th President of the Irish Hotels Federation. A native of Co. Leitrim and a graduate of Queens University Belfast and Cornell State University, he is owner manager of the Bush Hotel, a three-star property located in the centre of Carrick-on-Shannon. Dating back to the eighteenth century, the 60-bedroom hotel is one of the oldest in Ireland. The Bush Hotel is widely recognised for its commitment to environmental sustainability and, in 2009, was the first hotel in Ireland to be awarded the European Union Eco Label, which recognises exceptionally high environmental management and performance. Joe has been an active member of the IHF for many years. He also serves as Chairman of Leitrim Tourism. He has held the position of Chair of the Sligo/Leitrim/Roscommon branch of the Federation and was previously a director of Fáilte Ireland North West.



Myles Dungan, Conference Chairman



He is currently a member of the Tourism Leadership Group and the Central Marketing Partnership Group.

He recently bought and is currently renovating the 110 bedroom Portlaoise Heritage Hotel. He also bought and developed The Crown Bar, Wexford. Colm has served on IHF Council for the past 7 years and has been a member of management for 5 of those years. Chair of VisitWexford, Colm also represents the IHF and Irelands Ancient East sitting on the recently formed Strategic Committee, Leisure Tourism Partnership with Failte Ireland and Tourism Ireland to consider strategies needed to sustain inbound growth and improve both the regional and seasonal distribution of tourism gains within the country.
