If you wish to hold interviews on the day of the onsite event, facilities will be available for you. You can schedule onsite interviews with Jobseekers through the <u>www.europeanjobdays.eu</u> platform. Please note that the interview rooms will be in a separate building nearby (100m from the main venue). Representatives of EURES Spain and EURES Ireland will assist employers and jobseekers on the day. The onsite event will finish at 18:00 pm, but you will be able to conduct online interviews through the <u>www.europeanjobdays.eu</u> platform during the following day, 18th November.

Please note that you will not be able to interview any interested candidates on the EOJD platform after the 18th of November so you will have to use your own channels such as Zoom, Teams or skype. Some candidates may have uploaded their CV in advance so please check for potential CVs in advance of the event so you can have them screened in advance.
